The promotion orders above are subject to the following conditions: -

- i. There is no DAR/SPE/Vig case pending/contemplated against the above-named employees. In the above table, S.No.2, Shri A Premkumar, LP/Mail/ED is charged with penalty of "Withholding of annual increment due on 01.07.2026 for a period of 24 months". However, the employee will undergo the penalty in the promoted cadre.
- ii. They have completed 5 lakh kilometers of actual footplate duties as Loco pilots or have completed 10 years of actual service as Loco pilots.
- iii. They should vacate Railway Quarters if any occupied by them. If they wish to retain the Quarters at the old station, they should apply for retention and obtain prior permission as per extant rules.
- iv. There will be a probation period of 12 months in the promoted grade.
- v. The promotion will take effect from the date of shouldering higher responsibilities.
- vi. They can exercise option for fixation of pay within a period of one month from the date of shouldering higher responsibilities. The fixation of pay of the employee mentioned above and grant of next increment will be regulated as per Rule 13 & 10 of RS(RP) Rules-2016 issued by Railway Board Letter No.PC-VII/2016/RSRP/1 (RBE 90/2016) dated 28.07.2016.
- vii. The employees mentioned in Para II above may exercise option within one month from the date of promotion to fix their pay either from the date of promotion or from the date of next increment under Rule 1313 (FR22) I a) 1 of R.II Ref. Railway Board Letter No.PC-VII/2016/I/6/2 dated 31.07.2017 (RBE 79/2017).
- viii. In case the employee does not exercise any option within the stipulated period, it may be noted that his pay will be fixed straight away from the date of promotion as envisaged under Rule 1313 (FR22) Ia)1 of R.II and no further option/revision is permissible.
- ix. As per CPO/MAS letter No.P(S)353/Court/Policy/Vol.II dated 17.10.2017, any wrongful promotion/excess payment detected subsequently will be subject to rectification and recovery.
- x. The promotions ordered above are purely provisional and subject to the final outcome of ongoing litigations/court cases on the subject.
- xi. The above employees are eligible for benefits on account of transfer since there is change in station involved.
