- The above transfer is agreed subject to the following conditions:-
1. The employee will take the seniority in the new seniority unit to which he is transferred as per extant orders applicable to Inter Divisional Mutual transfer (ie) he will either retain his own seniority or take the seniority of the other in the new seniority unit to which he is posted, whichever is lower.
2. He will not seek re-transfer to his parent Unit/Railway at a later date.
3. He is not eligible for any transfer benefits on transfer account as the transfers are agreed to at his own request.
4. He will retain his lien in the Parent Department's seniority unit until he is permanently absorbed in

the new seniority unit to which he is posted.

5. He should be free from DAR/SPE/Vig cases as on date of his relief.

6. He may vacate any quarters occupied by him. If he wishes to retain the quarters as per extant rules, he has to apply to Sr.DPO/PGT for retention of the quarters at the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.

7. In terms of Railway Board's letter No.E(NG)-1/2006/TR/6 dated 21.04.2006 (RBE No: 53/2006), no request for backtracking from the above employee from the mutual exchange to be entertained in any circumstances.
